

D. Investigation: On 07/12/16 at 1805 hrs I (Ofc Bernardoni) responded to Kohl's, 11485 Twentymile Rd (Town of Parker), on a vehicle fire. I arrived on scene to find the interior of a silver Nissan Murano, CO LI# VANHLN, completely filled with smoke. I did not initially see flames. However, after I retrieved my fire extinguisher, I observed flaming plastic dripping down onto the right front tire from inside the engine compartment. I attempted to douse the flames by spraying the extinguisher up into the wheel well and onto the top of the front right dashboard to no avail. The flames continued to grow, eventually immolating the entire dash and console and melting the windshield.

SMFR arrived on scene at 1809 hrs and put out the fire. Fire Investigators may be requesting BWC video for their report.

The owner of the vehicle, Susan Bruner (02/13/65), had exited the Nissan prior to my arrival. She told me that she had noticed an electrical burning odor when she started the vehicle and then the ignition would not shut off.
